

# **Code of Practice on Alternative Remuneration in the Wealth Management Industry**

**Adopted by the Financial Planning Association (FPA) and Investment & Financial Services Association Ltd (IFSA) on the 1<sup>st</sup> August 2004.**

**Barnett Lilley & Associates Pty Ltd has adopted the code, effective 1/1/2005, with the Compliance Officer appointed to ensure compliance and deal with requests for the public register.**

*What is meant by 'alternative remuneration'?*

Alternative forms of remuneration occur under arrangements that provide certain material benefits, other than the payment of commission and service fees, to be obtained by a representative or licensee from a funds manager (or any other third party) in return for using that funds manager's product or platform.

The 'materiality test' will apply to alternative remunerations with items less than \$300 in value not considered material. Any form of remuneration that is over \$300 in value, per transaction or item, is considered 'material' therefore subject to the code and will be recorded in the public register.

The 'Alternative Form of Remuneration Register' outlines the alternative forms of remuneration which are paid and received from givers and receivers. Registers are maintained by Fund Managers, IDSP (platform) providers, Representatives and Licensees. Our registers are available for inspection on request and on our website.

Under the code no volume based arrangements are allowed such as bonuses, sponsorships or free participation in a conference where this is a reward for the volume of sales that has been made. If however an offer of sponsorship, conference participation or anything else that might be perceived as exerting an influence which is not linked to the volume of sales may be accepted but should be declared in the public register.

The register is to be updated at least quarterly, on an incidence basis, and BL&A has decided to record all remunerations considered not to be material (ie both under & over \$300) to demonstrate our full disclosure in this area.
